

**WAIVER AND RELEASE OF LIABILITY
-- READ BEFORE SIGNING:**

In consideration of being allowed to participate in any way in the Tour de Stooges on May 5, 2012, in Highland, Illinois, the St. Louis Cycling Club and Belleville Area Bicycling and Eating Society program, its related events and activities, I acknowledge, appreciate, and agree that:

1. The risk of injury from the activities involved in this program/event is significant. The activities involved in this program will expose me to certain risks associated with riding a bicycle including, but not limited to, falling, colliding, encountering vehicle traffic, adverse weather conditions, obstacles and/or debris along the traveled surface, uneven, slick and/or other dangerous surface conditions, and many other risks of danger. Such risks and dangers may lead to serious injuries including permanent injuries, paralysis and even death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, if I observe any unusual significant hazard during my presence of participation, I will remove myself from participation and bring such to the attention of the Event Organizers immediately; and,

4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS, **THE ST. LOUIS CYCLING CLUB, THE BELLEVILLE AREA BICYCLING AND EATING SOCIETY, THE CITY OF HIGHLAND, ILLINOIS**, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law. I agree to follow all the laws of the road which apply to cars and bicycles. **I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.**
